



Admissions Policy

Wales: NMS
1.2, 2.1, 2.2, 5.1, 16.1 - 16.3, A12, A13

At Wibli Wobli Nursery we care for up to 40 children between the ages of 2 and 5 years. We will be looking to apply in due course for children between the ages of 0 and 5 years.

The above is in accordance with the legal space requirements from statutory guidance e.g. NMS, and is the overriding policy in respect of admissions.

We take the following matters into account when prioritising and deciding on admissions which child can be offered a place in the nursery :

- A child currently attending nursery wanting to increase their sessions will be given priority over children on our waiting list
- Availability of places, taking into account the staff: child ratios, the age of the child and any registration requirements
- Children who have siblings who are already with us
- When the application is received (extra weight is given to those who have been on the waiting list the longest)
- The nursery's ability to provide the facilities necessary for the welfare of the child, including appropriate staffing arrangements
- Any extenuating circumstances affecting the child's welfare or the welfare of his/her family.

The nursery manager or someone designated by the nursery manager will check the list at regular intervals to check that parents who have expressed an interest in a place still require that place.

We operate an inclusion and equality policy and ensure that all children have access to nursery places and services irrespective of their gender, race, disability, religion or belief or sexual orientation of parents.

Prior to a child attending nursery, parents must complete and sign a contract and registration form. These forms provide the nursery with personal details relating to the child. For example, name, date of birth, address, emergency contact details, parental responsibilities, dietary requirements, collection arrangements, fees and sessions, contact details for parents, doctor's contact details, health visitor contact details, allergies, parental consent and vaccinations etc.


We aim to apply to deliver the Childcare Offer for Wales (30hrs funded early education and childcare)

- Pan dderbynnir y cais (rhoddir pwysau ychwanegol ar y rhai sydd wedi bod ar y rhestr aros hiraf)
- Gallu'r feithrinfa i ddarparu'r cyfleusterau angenrheidiol ar gyfer lles y plentyn, gan gynnwys trefniadau staffio priodol
- Unrhyw amgylchiadau esgusodol sy'n effeithio ar les y plentyn neu les ei deulu.

Bydd rheolwr y feithrinfa neu rywun a ddynodwyd gan reolwr y feithrinfa yn gwirio'r rhestr yn rheolaidd i wirio bod rhieni sydd wedi mynegi diddordeb mewn lle yn dal angen y lle hwnnw.


