



ACCIDENTS AND FIRST AID POLICY

At Wibli Wobli Nursery the safety of all children is paramount and we have measures in place to help to protect children. However, sometimes accidents do unavoidably happen. We follow this policy and procedure to ensure all parties are supported and cared for when accidents or incidents happen; and that the circumstances of the accident or incident are reviewed with a view to minimising any future risks.

Accidents

When an accident or incident occurs, we ensure:

- The child is comforted and reassured first
- The extent of the injury is assessed and if necessary, a call is made for medical support and/or an ambulance
- First aid procedures are carried out where necessary, by a trained paediatric first aider
- The person responsible for reporting accidents, incidents or near misses is the member of staff who saw the incident or was first to find the child where there are no witnesses
- The accident or incident is recorded on an accident/incident form and it is reported to the nursery manager. Other staff who have witnessed the accident may also countersign the form, and in more serious cases provide a statement. This should be done as soon as the accident is dealt with, whilst the details are still clearly remembered
- Parents are shown the accident/incident report and informed of any first aid treatment given when collecting the child. They are asked to sign the record of any accidents/incidents to acknowledge the entry
- The nursery manager reviews the accident/incident forms at least monthly for patterns, e.g. one child having a repeated number of accidents, a particular area in the nursery or a particular time of the day when most accidents happen. Any patterns are investigated by the nursery manager and all necessary steps to reduce risks are put in place
- The nursery manager reports any serious accidents/incidents to the registered person for investigation for further action to be taken (i.e. a full risk assessment or report under Reporting of Injuries, Diseases and Dangerous Occurrences Regulations (RIDDOR))
- The accident file is kept for at least 21 years and three months
- Where medical attention is required, a senior member of staff will notify the parent(s) as soon as possible whilst caring for the child appropriately
- Where medical treatment is required the nursery manager will follow the insurance company procedures, which may involve informing them in writing of the accident
- The nursery manager will report any accidents of a serious nature to CIW and the local authority child protection team, where necessary, following the guidance set out in serious accidents, injuries and deaths that registered providers must notify to CIW and local child protection agencies Notification must be made as soon as is reasonably practical, but in any event within 14 days of the incident occurring. Where relevant such accidents will also be reported to the local authority environmental health department or the Health and Safety Executive and their advice followed.

Head Injuries

If a child has a head injury in the setting then we will follow the following procedure:

- Comfort, calm and reassure the child
- Assess the child's condition to ascertain if a hospital or ambulance is required. We will follow our procedure for this if this is required (see below)
- If the skin is not broken we will administer a cold compress for short periods of time, repeated until the parent arrives to collect their child
- If the skin is broken then we will follow our first aid training and stem the bleeding
- Call the parent and make them aware of the injury and if they need to collect their child
- Complete the accident form
- Keep the child in a calm and quiet area whilst awaiting collection, where applicable
- We will continue to monitor the child and follow the advice on the NHS website as per all head injuries <https://www.nhs.uk/conditions/minor-head-injury/>
- For major head injuries we will follow our paediatric first aid training.

Transport children to hospital procedure

The nursery manager/staff member must:

- Call for an ambulance immediately if the injury is severe. We will not attempt to transport the injured child in our own vehicles
- Whilst waiting for the ambulance, contact the parent(s) and arrange to meet them at the hospital
- Arrange for the most appropriate member of staff to accompany the child taking with them any relevant information such as registration forms, relevant medication sheets, medication and the child's comforter.
- Redeploy staff if necessary to ensure there is adequate staff deployment to care for the remaining children. This may mean temporarily grouping the children together
- Inform a member of the management team immediately
- Remain calm at all times. Children who witness an incident may well be affected by it and may need lots of cuddles and reassurance. Staff may also require additional support following the accident.

First aid

The location of the children first aid boxes is set out in the **Schedule – Accident Emergency Useful Information** below. These are accessible at all times with appropriate content for use with children. The appointed person responsible for first aid checks the contents of the boxes regularly and replaces items that have been used or are out of date.

The location of the staff first aid box is set out in the **Schedule – Accident Emergency Useful Information** below. This is kept out of reach of the children.

First aid boxes should only contain items permitted by the Health and Safety (First Aid) Regulations Act 1981, such as sterile dressings, bandages and eye pads. No other medical items, such as paracetamol should be kept.

The appointed First Aid officer is set out in the **Schedule – Accident Emergency Useful Information** below.

All of the staff are trained in paediatric first aid as part of their induction and this training is updated every three years. We comply with the general first aid at work training requirements set out by the Health and Safety Executive in relation to our employees.

All first aid trained staff are listed in every room. When children are taken on an outing away from our nursery, we will always ensure they are accompanied by at least one member of staff who is trained in paediatric first aid. A first aid box is taken on all outings, along with any medication that needs to be administered in an emergency including inhalers etc.

Food safety and play

Children are supervised during meal times and food is adequately cut up to reduce the risk of choking. The use of food as a play material enables learning experiences through exploring different malleable materials. The following may be used. These are risk assessed and presented differently to the way it would be presented for eating e.g. in trays:

- Playdough
- Cornflour
- Dried pasta, rice and pulses

Food items may also be incorporated into the role play area to enrich the learning experiences for children, e.g. Fruits and Vegetables. Children will be fully supervised during these activities. Food that could cause a choking hazard including raw jelly is not used.

Personal protective equipment (PPE)

The nursery provides staff with PPE according to the need of the task or activity. Staff must wear PPE to protect themselves and the children during tasks that involve contact with bodily fluids. PPE is also provided for domestic tasks. Staff are consulted when choosing PPE to ensure all allergies and individual needs are supported and this is evaluated on an ongoing basis.

Dealing with blood

We may not be aware that any child attending the nursery has a condition that may be transmitted via blood. Any staff member dealing with blood must:

- Always take precautions when cleaning wounds as some conditions such as hepatitis or the HIV virus can be transmitted via blood
- Wear disposable gloves, disposable aprons and wipe up any blood spillage with disposable cloths, neat sterilising fluid or freshly diluted bleach (one part diluted with 10 parts water). Such solutions must be carefully disposed of immediately after use.

Needle puncture and sharp injury

We recognise that injuries from needles, broken glass and so on may result in blood borne infections and that staff must take great care in the collection and disposal of this type of material. For the safety and well-being of the employees, any staff member dealing with needles, broken glass etc. must treat them as contaminated waste. If a needle is found the local authority must be contacted to deal with its disposal.

At Wibli Wobli Nursery we treat our responsibilities and obligations in respect of health and safety as a priority and we provide ongoing training to all members of staff which reflects best practice and is in line with current health and safety legislation. This policy is updated at least annually in consultation with staff and parents and/or after a serious accident or incident.

Outings

For all outings, there must be at least one member of staff present who holds a current first aid qualification. A fully stocked, portable first aid kit must be taken on every outing and be readily accessible at all times. Staff must also carry a nursery mobile phone to ensure a reliable means of communication in case of an emergency. Staff are responsible for checking that the first aid kit is complete and in date prior to departure and that the mobile phone is fully charged and operational, and for ensuring both remain with the group at all times.

POLISI DAMWEINIAU A CHYMORTH CYNTAF

Ym Meithrinfa Wibli Wobli mae diogelwch pob plentyn yn hollbwysig ac mae gennym fesurau ar waith i helpu i amddiffyn plant. Fodd bynnag, weithiau mae damweiniau'n digwydd yn anochel. Rydym yn dilyn y polisi a'r weithdrefn hon i sicrhau bod pob parti yn cael ei gefnogi a'i ofalu amdanynt pan fydd damweiniau neu ddigwyddiadau'n digwydd; a bod amgylchiadau'r ddamwain neu'r digwyddiad yn cael eu hadolygu gyda'r bwriad o leihau unrhyw risgiau yn y dyfodol.

Damweiniau

Pan fydd damwain neu ddigwyddiad yn digwydd, rydym yn sicrhau:

- Mae'r plentyn yn cael ei gysuro a'i dawelu yn gyntaf
- Mae maint yr anaf yn cael ei asesu ac os oes angen, gwneir galwad am gymorth meddygol a/neu ambiwlans
- Mae gweithdrefnau cymorth cyntaf yn cael eu cynnal lle bo angen, gan gynorthwydd cyntaf pediatriig hyfforddedig
- Y person sy'n gyfrifol am adrodd am ddamweiniau, digwyddiadau neu ddamweiniau agos yw'r aelod o staff a welodd y digwyddiad neu oedd y cyntaf i ddod o hyd i'r plentyn lle nad oes tystion
- Mae'r ddamwain neu'r digwyddiad yn cael ei gofnodi ar ffurflen ddamwain/digwyddiad ac fe'i hadroddir i reolwr y feithrinfa. Gall staff eraill sydd wedi gweld y ddamwain hefyd gydlofnodi'r ffurflen, ac mewn achosion mwy difrifol ddarparu datganiad. Dylid gwneud hyn cyn gynted ag y delir â'r ddamwain, tra bod y manylion yn dal i gael eu cofio'n glir
- Mae'r rhieni'n cael eu dangos yr adroddiad damwain/digwyddiad a'u hysbysu am unrhyw driniaeth cymorth cyntaf a roddir wrth gasglu'r plentyn. Gofynnir iddynt lofnodi cofnod unrhyw ddamweiniau/digwyddiadau i gydnabod y cofnod
- Mae rheolwr y feithrinfa'n adolygu'r ffurflenni damwain/digwyddiad o leiaf yn fisol am batrymau, e.e. un plentyn yn cael nifer o ddamweiniau dro ar ôl tro, ardal benodol yn y feithrinfa neu amser penodol o'r dydd pan fydd y rhan fwyaf o ddamweiniau'n digwydd. Mae rheolwr y feithrinfa yn ymchwilio i unrhyw batrymau a rhoddir pob cam angenrheidiol ar waith i leihau risgiau.

- Wrth aros am yr ambiwlans, cysylltu â'r rhiant(iaid) a threfnu i gyfarfod â nhw yn yr ysbyty.
- Trefnu i'r aelod staff mwyaf priodol fynd gyda'r plentyn gan fynd ag unrhyw wybodaeth berthnasol gyda nhw fel ffurflenni cofrestru, taflenni meddyginiaeth perthnasol, meddyginiaeth a chysurwr y plentyn.
- Ail-leoli staff os oes angen i sicrhau bod digon o staff yn cael eu defnyddio i ofalu am y plant sy'n weddill. Gall hyn olygu grwpio'r plant gyda'i gilydd dros dro.
- Hysbysu aelod o'r tîm rheoli ar unwaith.

Mae'r holl staff wedi'u hyfforddi mewn cymorth cyntaf pediatriig fel rhan o'u sefydlu ac mae'r hyfforddiant hwn yn cael ei ddiweddarau bob tair blynedd. Rydym yn cydymffurfio â'r gofynion hyfforddi cymorth cyntaf cyffredinol yn y gwaith a nodir gan yr Awdurdod Gweithredol Iechyd a Diogelwch mewn perthynas â'n gweithwyr.

Mae'r holl staff sydd wedi'u hyfforddi mewn cymorth cyntaf wedi'u rhestru ym mhob ystafell. Pan fydd plant yn cael eu mynd ar driip i ffwrdd o'n meithrinfa, byddwn bob amser yn sicrhau eu bod yng nghwmni o leiaf un aelod o staff sydd wedi'i hyfforddi mewn cymorth cyntaf pediatriig. Cymerir blwch cymorth cyntaf ar bob trip, ynghyd ag unrhyw feddyginiaeth y mae angen ei rhoi mewn argyfwng gan gynnwys anadlyddion ac ati.

Diogelwch a Chwarae Bwyd

Mae plant yn cael eu goruchwyllo yn ystod prydau bwyd ac mae bwyd yn cael ei dorri'n ddigonol i leihau'r risg o dagu. Mae defnyddio bwyd fel deunydd chwarae yn galluogi profiadau dysgu trwy archwilio gwahanol ddefnyddiau hyblyg. Gellir defnyddio'r canlynol. Mae'r rhain yn cael eu hasesu o ran risg a'u cyflwyno'n wahanol i'r ffordd y byddai'n cael ei gyflwyno i'w fwyta e.e. mewn hambyrddau:

- Toes chwarae
- Blawd corn
- Pasta sych, reis a chodlysiau

Gellir ymgorffori eitemau bwyd yn yr ardal chwarae rôl hefyd i gyfoethogi'r profiadau dysgu i blant, e.e. Ffrwythau a Llysiau. Bydd plant yn cael eu goruchwyllo'n llawn yn ystod y gweithgareddau hyn. Ni ddefnyddir bwyd a allai achosi perygl tagu gan gynnwys jeli amrwd.

Cyfarpar Diogelu Personol (CDP)

Mae'r feithrinfa'n darparu CDP i'r staff yn ôl anghenion y dasg neu'r gweithgaredd. Rhaid i'r staff wisgo CDP i amddiffyn eu hunain a'r plant yn ystod tasgau sy'n cynnwys cyswllt â hylifau'r corff. Darperir CDP hefyd ar gyfer tasgau domestig. Ymgynghorir â staff wrth ddewis CDP i sicrhau bod pob alergedd ac anghenion unigol yn cael eu cefnogi a chaiff hyn ei werthuso'n barhaus.

Ymdrin â gwaed

Efallai nad ydym yn ymwybodol bod gan unrhyw blentyn sy'n mynychu'r feithrinfa gyflwr a allai gael ei drosglwyddo trwy waed. Rhaid i unrhyw aelod o staff sy'n ymdrin â gwaed:

- Bob amser gymryd rhagofalon wrth lanhau clwyfau gan y gellir trosglwyddo rhai cyflyrau fel hepatitis neu'r firws HIV trwy waed
- Gwisgo menig tafladwy, ffedogau tafladwy a sychu unrhyw waed sydd wedi'i ollwng gyda lliain tafladwy, hylif sterileiddio taclus neu gannydd newydd ei wanhau (un rhan wedi'i wanhau â 10 rhan o ddŵr). Rhaid cael gwared ar doddiannau o'r fath yn ofalus ar unwaith ar ôl eu defnyddio.

Tyllu nodwydd ac anaf miniog

Rydym yn cydnabod y gall anafiadau o nodwyddau, gwydr wedi torri ac yn y blaen arwain at heintiau a gludir yn y gwaed a bod yn rhaid i staff gymryd gofal mawr wrth gasglu a gwaredu'r math hwn o ddeunydd. Er diogelwch a lles y gweithwyr, rhaid i unrhyw aelod o staff sy'n delio â nodwyddau, gwydr wedi torri ac ati eu trin fel gwastraff halogedig. Os canfyddir nodwydd, rhaid cysylltu â'r awdurdod lleol i ddelio â'i gwaredu.

Yn Meithrinfa Wibli Wobli rydym yn trin ein cyfrifoldebau a'n rhwymedigaethau o ran iechyd a diogelwch fel blaenoriaeth ac rydym yn darparu hyfforddiant parhaus i bob aelod o staff sy'n adlewyrchu arfer gorau ac sy'n unol â deddfwriaeth iechyd a diogelwch gyfredol. Caiff y polisi hwn ei ddiweddarau o leiaf yn flynyddol mewn ymgynghoriad â staff a rhieni a/neu ar ôl damwain neu ddigwyddiad difrifol.

Teithiau

Ar gyfer pob daith, rhaid bod o leiaf un aelod o staff yn bresennol sydd â chymhwyster cymorth cyntaf cyfredol. Rhaid mynd â phecyn cymorth cyntaf cludadwy, wedi'i stocio'n llawn ar bob daith a bod ar gael yn rhwydd bob amser. Rhaid i staff hefyd gario ffôn symudol y feithrinfa i sicrhau dull cyfathrebu dibynadwy rhag ofn argyfwng.
